Provisions applying if the student does not successfully complete some of the components:

If the student does not earn all the ECTS credits awarded to the programme (or equivalent), he is declared to have failed the semester or year by the examination board and must then re-register the following academic year at the University of Caen Normandie. The examination board will decide which of the French courses on the semester or year curriculum are validated, taking into account the number of ECTS credits (or equivalent) earned at the host university, and which remain to be validated by the student for the semester or year.

II. COMMITMENT OF THE 3 PARTIES
